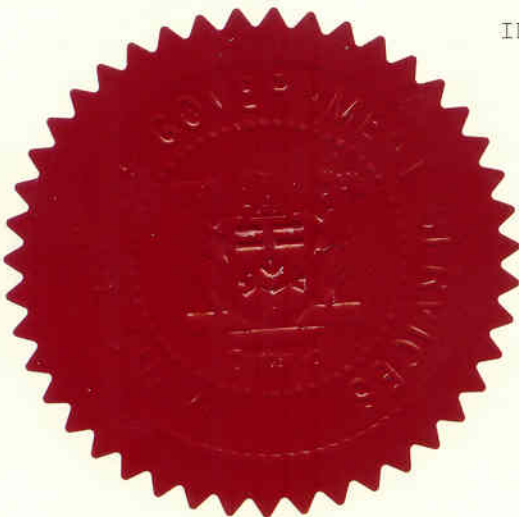

To Whom It May Concern:

This letter certifies that Ontario International College, located at 4580 Dufferin St, Ste 600, Toronto, Ontario, is registered as a private school with the Ontario Ministry of Education in school year 2009-10 under BSID 666777, further to section 16 of the *Education Act* (the Act). The school has been registered with this ministry since 2003.

The school offers credits in subjects leading to the Ontario Secondary School Diploma (OSSD) and is inspected by the Ministry of Education.

Students who have completed all diploma requirements are granted an Ontario Secondary School Diploma.
